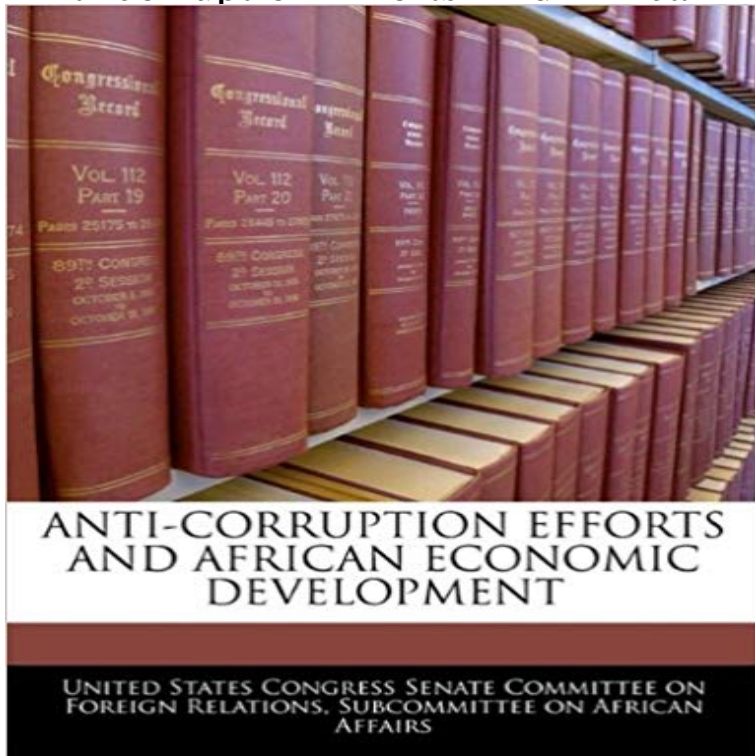


Anti-corruption Efforts And African Economic Development
